1. Venue and opening times for visitors to the event:

Thursday, 17.05.2012 at 10:00 clock and ends at 18.00 clock.
Friday on the 18.05.2012 at 10.00 to 17.00 clock.
Saturday on the 19.05.2012 at 09.00 to 17.00 clock
Sunday on the 20.05.2012 at 09.00 to 14.00 clock.

The body can be from Tuesday to 15.05. from 10.00 - 20.00 clock and
Wednesday 16.05. from 10.00 to 22.00 clock,
Thursday, 17.06. at 06.00 to 09.30 clock.

2. Exhibits, products range:

Artist bears, artist dolls, antique teddy bears, antique dolls, stuffed toys, miniatures, tin toys,
Toy accessories and any type of collector toys.

3. Approval:

The event, any collector or any private person or any commercial traders from the

5. Registration, withdrawal and prior reservation:

The reservation and stands will be done by the organizer in order of written

Subletting is strictly prohibited! Cancellations in writing before (insured) to 6 weeks

6. Exhibition space, and dismantling of the stand:

The specified limits are observed. Corridors and escape routes must always be kept free.
Instructions of supervisory personnel or the fire department are to follow.
Dismantling is only at the
specified time allowed,
Anyone who breaks down earlier, damages the reputation of the event and will
be allowed again. Furthermore,
is the tenant of the floor space with a penalty in the amount of the rental
occupied!

7. Exhibitor Passes:

The Exhibitor badges must be worn visibly during the event. They are
not transferable. Non-compliance can immediately leave the party, be required.

8. Cleaning of the stand:

The cleaning of the stand after the end of the event will be for each exhibitor, otherwise
is 50,- € cleaning fee charged.

9. Name and address on the stand:

Because of the conditions attached by the police, each exhibitor's full address with visible
from written-names, name, street, house number and zip code and place on the stand.

10. Pricing:

customs!
